AN ORDINANCE DEPUTIZING BARANGAY SANITATION INSPECTORS IN 19 BARANGAYS OF PANGANTUCAN, BUKIDNON WITH THEIR DUTIES AND RESPONSIBILITIES, AND PROVIDING MONTHLY HONORARIUM THEREOF.

BE IT ENACTED by the 16th Sangguniang Bayan of Pangantucan, Bukidnon in session assembled, that:

SECTION 1: TITLE & SCOPE

-This Ordinance shall be known as "Barangay Sanitation Inspectors Ordinance" in the Local Government Unit of Pangantucan, Bukidnon.

-This Ordinance applies only to the deputized Barangay Sanitation Inspectors in the 19 barangays of Pangantucan, Bukidnon.

SECTION 2: DUTIES AND RESPONSIBILITIES

Administrative Matters

- a. Prepares environmental sanitation programs on your area of assignment.
- b. Participates in the total planning for the community and attend community meetings, conferences, training activities and the like.
- c. Prepares sanitation reports and maintains proper filing system and updates sanitation records upon the supervision of the Municipal Sanitary Inspector.
- d. Establishes and maintains linkages with different community organizations and other barangay organizations.

Technical Concerns on Environmental Sanitation

- a. **Water Sanitation** - Responsible in the provision and maintenance of safe and adequate water supply to the community
- b. **Food Sanitation**- Responsible in the provision of safe and wholesome food to consumers through proper enforcement of sanitation rules and regulations and the training of food operators and food handlers.

- c. **Waste Management**- Responsible in the enforcement of rules and regulations on excreta and sewage collection and disposal, solid waste and health care waste management.
- d. **Vermin Control** - Responsible in the elimination of breeding and harborage places of vermin and the conduct or guide of organized control program.
- e. **Industrial Hygiene** - Responsible in the enforcement of sanitation rules and regulations of industrial establishment and industrial waste.
- f. **Public places Sanitation** - responsible in the provision of sanitary facilities and maintenance of the sanitary condition in public places like schools, public laundry, camps and picnic grounds, bus terminal , tonsorial and beauty establishments.
- g. **Emergency Sanitation** - responsible for the provision of sanitary toilet facilities, provisions of safe water and maintenance of sanitary conditions of the evacuation sites or affected areas.
- h. **Health Education** - responsible in the implementation of health education activities including community organizing related to environmental sanitation.
- i. **Routine inspection** - carries out routine inspection in accordance with the standard frequency for the different fields of environmental sanitation, using the prescribed form.

Section 3 **ADMINISTRATIVE PROVISION**

The Municipal Sanitary Inspector can recommend to the Punong Barangays for disciplinary measures of their appointed Barangay Sanitary Inspector.

Section 4 **APPOINTMENT OF BARANGAY SANITARY INSPECTOR.**

The Local Chief Executive of the barangay shall be responsible for the appointment of the barangay sanitary inspectors who are preferably High School graduate from any High School institutions may it be public or a private school.

Section 5 **COMPENSATION AND REMUNERATION.**

The Barangay Sanitation Inspector shall receive a monthly honorarium amounting to Five Hundred Pesos (500.00) chargeable against the General Fund of this Municipality totaling the amount of One Hundred Fourteen Thousand (Php114,000.00) to be funded every year and thereafter.

Section 6 **SEPARABILITY CLAUSE**

Should any provisions of this Ordinance or any part thereof be declared invalid, the other provisions, insofar as they are separable from the invalid ones, shall remain in full force and effect.

Section 7 **REPEALING CLAUSE**

All ordinances and orders inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 8 **EFFECTIVITY**

This Ordinance shall take effect after its copies are posted in the bulletin board of the Municipal Hall and in other two conspicuous places within three consecutive weeks.
