A RESOLUTION REQUESTING THE HONORABLE MAYOR, MIGUEL A. SILVA, JR., TO CAUSE THE REVISION OF THE COMPREHENSIVE LAND USE PLAN (CLUP) OF THIS MUNICIPALITY AND TO ALLOCATE BUDGET IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FOR THE PURPOSE.

WHEREAS, this Office was in receipt of a letter from of the Mayor dated September 14, 2017, requesting the Sangguniang Bayan to allow the landowners of Barangay New Eden to lease their titled agricultural lands to the banana producer companies;

WHEREAS, as course of action towards the request, the Sangguniang Bayan passed Resolution No. 370, series of 2017, which denied the landowners' request attributable to the fact that the lands sought to be leased are within the protected zone as indicated in the Comprehensive Land Use Plan (CLUP) of this municipality;

WHEREAS, the landowners engaged the services of a Counsel in the person of Atty. Febbie A. Cupida-Legita and submitted to this Office a letter dated November 21, 2017, requesting the august Body to reconsider SB Resolution No. 370, series of 2017 and the same was jointly referred to the Committees on Rules, Laws, Privileges, and Civil Service and on Agriculture and Cooperatives, Trade and Industry, and Agrarian Reform, and Environment and Natural Resources;

WHEREAS, in aid of legislation, the joint Committees conducted hearings last November 28, 2017 and on January 9, 2018 so as to consider the matter wherein it was determined thru a common agreement by the members that the landowners' request could not be granted unless the CLUP is amended;

WHEREAS, in such series of hearings, the landowners implored to consider their respective plights and do

something about the CLUP for them to be allowed to lease their land to the multi-national companies;

WHEREAS, it is now timely to cause the amendment of the CLUP in view of the fact that it has been already 5 years since its formulation and doing so is permissible as per information from the Housing and Land Use Regulatory Board (HLURB) so long as the amendment will undergo the same process when it was crafted;

WHEREAS, amending the CLUP is coupled with corresponding budget; hence, since the Sanggunian can only review and approve budgets, this expression requests the Honorable Mayor, Miguel A. Silva, Jr., to allocate One Million Pesos (P1,000,000.00) to defray the expenses of the said undertaking.

NOW THEREFORE:


