### **EXECUTIVE ORDER NO.175**

Series of 2021

#### **“AN ORDER ESTABLISHING A TEMPORARY PARKING SCHEME IN THIS MUNICIPLAITY”**

**WHEREAS**, President Rodrigo Roa Duterte, directed the public officials thru the Department of the Interior and Local Government to exercise their full authority to reclaim public roads which are being used for private ends and get rid of illegal obstructions, structures and constructions, particularly along public roads and streets.

**WHEREAS**, the Department of the Interior and Local Government issued Memorandum Circular No. 2020-027 and 2020-145 addressed to All Provincial Governors, City and Municipal Mayors, Punong Barangays, Heads of Local Sanggunians, DILG Regional Directors, BARMM Regional Governor and all others concerned.

**WHEREAS**, in the said Memorandum Circular, Local Governments must enact or revisit ordinances related to road clearing and banning of illegal construction; prepare an inventory of roads within their jurisdiction; develop and implement displacement strategies; and cause the rehabilitation of recovered public roads.

**WHEREAS**, the construction of the new public terminal is still on-going leaving no space for some private vehicles to park, making them park illegally along public roads of this Municipality.

**WHEREAS**, illegally parked vehicles are considered as obstruction on public roads and are subjected to the road clearing displacement strategy in which they are given temporary parking spaces along one-way roads of this Municipality.

**NOW THEREFORE, I MIGUEL A. SILVA, JR.** Municipal Mayor of Pangantucan, Bukidnon, by virtue of the powers vested upon me by law do hereby order:

**SECTION 1.** The creation of a temporary parking scheme through which displaced parked vehicles are authorized to park on one-way road parts designated temporarily for parking until the construction the new Public Terminal is completed.

**SECTION 2.** The left side lane of the following one-way roads shall be designated as the authorized temporary parking for any vehicles in this municipality;

- a. Molave St. (from national highway to M. Ontejo St. intersection)
- b. M. Ontejo St. (from Gorge Tower Mall to Park n' Go)


c. Sabado St. (from national highway to M. Ontejo St. intersection)

**SECTION 3. Repealing Clause.** All issuances and other executive orders which are inconsistent with or contrary with this Executive Order are hereby repealed, amended or modified accordingly.

**SECTION 4. Effectivity.** This order shall take effect immediately.
