AN ORDER RE-ORGANIZING THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THIS LOCAL GOVERNMENT UNIT OF PANGANTUCAN BUKIDNON.

WHEREAS, Section 43 (b) of RA 6975 states that x x x x x x. The term of office of the members of the PLEB shall be a period of three (3) years from the assumption of office. Such member shall hold office until his successor shall have been chosen and qualified;

WHEREAS, the existing E.O, re: An Order Amending EO No. 115-08-02 series of 2007, reactivating the People's Law Enforcement Board (PLEB) to act on complaints against erring Police Officers, was issued on January 10,2011 and such order takes effect until at present;

WHEREAS, the Liga ng mga Barangay as well has designated PB Reynold Rodriguez II as the Liga ng mga Barangay representative to the PLEB through its Resolution No. 2, series of 2014;

WHEREAS, the Municipal Peace and Order Council, during its regular meeting held on November 18,2015, has likewise nominated five (5) individuals from whom the Local Chief Executive shall choose to constitute the three (3) other members of PLEB coming from the community;

WHEREAS, the existing EO of 2011 issued by the Local Chief Executive needs to be updated and revised to abide by the provisions of R.A 6975, known as an Act Establishing the National Police under a reorganized department of the Interior and Local Government, and for other purposes.

NOW THEREFORE:

I, **MIGUEL A. SILVA JR.**, Municipal Mayor of Pangantucan, Bukidnon, by virtue of the powers vested in me by law and based on the foregoing premise stated above, hereby ordain the reorganization of the People's Law Enforcement Board (PLEB) of this Municipality, to wit:

Section 1. Composition - The PLEB shall be composed of the following:


Section 2. Officer - The Chairman of the PLEB shall be elected from among its members on the date specified in their existing internal rule of procedures regarding regular meeting. The term of office of the members of the PLEB shall be three (3) years from assumption of office.

Section 3. Duties and Functions - The PLEB shall have jurisdiction to hear and decide people's complaint or cases filed before it against erring officers and members of the Philippine National Police.

Section 4. Repealing Clause - All orders and others issuances found inconsistent with this ORDER are hereby repealed or amended accordingly.

Section 5. Effectivity - This Order shall take effect immediately after its approval.
